Lines 18 & 19: Hickory Knolls foreclosure action

Line 21: Take legal action to force mortgage company to complete the foreclosure

Al Atzert motioned to move forward with foreclosure action on Lines 18 and 19. Laura Monette seconded, none opposed and motion carried.

Al Atzert motioned to send a letter to 811 Hickory Knolls Drive regarding the overgrown hedges, fence and gate in disrepair, notifying homeowner that legal action will be taken at owner's expense if not completed. Shannon Kolacz seconded, none opposed and motion carried.

Management to have attorney send a letter regarding parking on the lawn at 3031 Majestic Oaks Lane and a three day notice to 2895 Majestic Oaks Lane regarding mowing.
